

MCCLARENS RUN BRIDGE #7 (LOCAL PROJECT)

• Let Date: 10/10/2024

• <u>Scope:</u> Replacement of existing concrete-encased steel Ibeam bridge on McClaren Rd over McClarens Run with 64-ft long, 16ft x 8.5ft precast box culvert. Project also includes a driveway adjustment, guide rail installation, and drainage improvements. Sewer line and gas line replacements will be performed via coordinated work.

 <u>Scope</u>: Installation of 0.25 miles of 8-ft wide asphalt pedestrian trail in Brackenridge Memorial Park along East 1st Ave. Project also includes the installation of ADA cub ramps and crosswalk markings as well as the abandonment/filling of an existing well.

SR 0136-A10 (RAINBOW RUN ROAD)

Scope: The existing crossing is a single span, concreteencased steel I-beam bridge and is in a deteriorated condition based on recent inspection. The project proposes to replace the crossing on the existing horizontal alignment with a single span box culvert bridge. The project will also replace the existing gabion basket wall in the upstream right overbank that supports SR 0136 with a Soldier Pile and lagging type wall. The vertical profile of the roadway will be maintained from existing to proposed conditions with minimal approach work. The proposed hydraulic opening will be slightly larger than the existing bridge.



SR 376 A62 COMMERCIAL STREET BRIDGE

Let Date: 4/11/2024

<u>Scope:</u> The scope of work for this project will consist of the total replacement of the Commercial Street Bridge on SR 376, carrying I-376 commonly known as the Parkway East, over Commercial Street, Nine Mile Run, and Frick Park within the City of Pittsburgh, Allegheny County. The structure will be replaced utilizing ABC Techniques where the new 5-Span Steel Arched Delta-Frame Structure will be erected on temporary substructure units and laterally slid into place along the existing alignment of SR 376. In addition to the bridge replacement the scope of work includes new sign structures, new retaining wall, pavement reconstruction, asphalt milling and resurfacing, guide rail updates, median barrier replacement, drainage, signing and pavement marking, ramp lowering, temporary roadway, temporary trail, sewer line relocation, landscaping, ITS upgrades, over height truck detection system relocation, and other miscellaneous construction. One early action items for this contract will be to lower SR 8012 Ramp G to increase the existing underpass clearance.
