Crisis Response Workshop

9 a.m. – 11 a.m. @ CAWP Offices

During this workshop, participants will learn best practices related to an internal, external, and community response based on industry related scenarios.

Horizontal Lifeline Competent Person

The Competent Person for Horizontal Lifeline course is designed for users of HLL fall protection equipment, their supervisors, and safety professionals. Attendees will learn the consensus standards, the inspection, installation, usage, and limitations of HLL and anchorage connectors. Additionally, will learn about connecting devices and storage practices.
