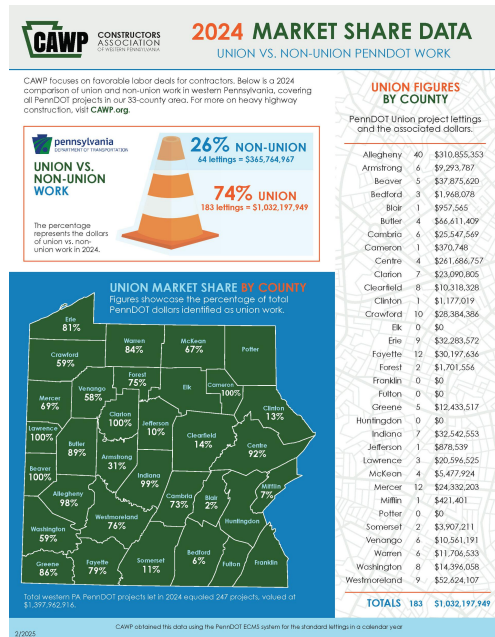
Annual Meeting Recap

On-Demand webinars are also available and offer the convenience of selecting the chapters you need or watching the entire webinar.

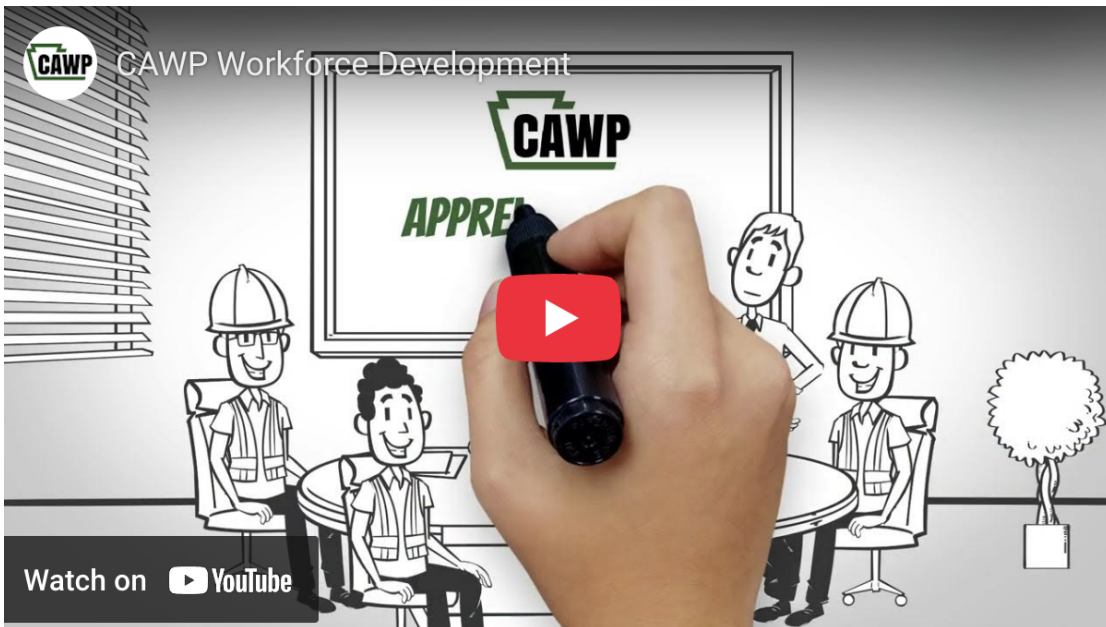
